PREAMBLE

1. The necessity of the research

Foreign direct investment has been playing an important role in economic development for many countries around the world. Foreign direct investment has brought many important advantages which can lead to technology transfer, know-how, improve access to international markets and promote competition. In Vietnam, the Law on Foreign Investment has been revised and expanded the autonomy for provincial governments in managing foreign investment such as issuing investment licenses, leasing land, providing import and export licenses and labor recruitment. This policy allows provincial governments to develop in a creative way that attracts more foreign investors and foreign investors can consider many factors when investing in Vietnam such as choosing a location that suitable to maximize investment efficiency.

Quang Ninh is one of the few localities with relatively favorable natural conditions and geographical position, an important transport hub to promote regional and international trade. From the early years of the renewal period, the Provincial Party Committee and the People's Committee of Quang Ninh province have clearly identified the comparative advantage, the trend of developing international economic integration and affirmed that attracting foreign direct investment is one of Important solutions for socio-economic development. Quang Ninh has gained important results (expanding and increasing the investment capital for development, increasing production capacity, contributing to economic restructuring, creating many new jobs for laborers, speeding up the process of renewing equipment, technology and management experience, expanding export markets, increasing revenue sources for the budget, ...) in order to boost the province's socio-economic development quickly and sustainably.

Quang Ninh has identified a strategy to attract foreign direct

investment, from trusted partners in developed countries with strengths: "Transport infrastructure, science and technology industry, clean industry, supporting industry, high-tech agriculture, environment; focusing on industrial and economic zones." Therefore, following the reduction of official assistance (ODA), foreign direct investment (FDI) from developed countries will be one of the most important strategic sources in the process of promoting rapid economic development of Quang Ninh in the future. However, since Quang Ninh attracted the first FDI project in 1990 to the present time, there are many FDI projects in the form of foreign direct investment but the rate of implementation is low (about 20%), FDI projects are not really effective, they also overlook many investment opportunities of high-tech enterprises and large-scale capital such as Japan, the United States, Singapore...

In the context that Vietnam is participating and implementing new-generation free trade agreements along with the shift in global value chains by focusing on building domestic link chains, adding value, raising High skills and innovation, along with the strong impact from the industrial revolution 4.0, with breakthrough technologies have made competition attract FDI in the region and in the world is getting more and more fierce. In order to achieve the above-mentioned goal of attracting foreign direct investment, the attraction of foreign direct investment plays an important and decisive role.

For the reasons mentioned above, the author's choice of thesis title "Investigation the attraction of foreign direct investment into Quang Ninh province in the context of new development" is scientific and practical in accordance with general socio-economic development orientations of the whole country and Quang Ninh province in particular in the new context.

2. Research purpose and tasks

2.1. Research purpose

The dissertation proposes a number of scientific and practical solutions to increase the attraction of foreign direct investment into Quang Ninh province in the new development context.

2.2. Research tasks

- + Systematizing common theory on foreign direct investment and the issue of attracting foreign direct investment into a country in general and a province at a particular level;
- + Analyzing the situation of attracting foreign direct investment capital into Quang Ninh province in the 2010-2019 period;
- + Evaluation of successes, limitations and causes of success, limitations of the situation of attracting FDI capital into Quang Ninh province;
- + Analysis of factors affecting FDI attraction into Quang Ninh province through exploratory factor analysis model (EFA) and linear structure model based on least squares (PLS-SEM)
- + Studying the system, synchronizing solutions to increase the attraction of FDI into Quang Ninh province in a new context.

3. Subjects and scope of research

3.1. Research subjects

The thesis focuses on researching theoretical and practical issues to attract FDI into the provincial level.

3.2. Research scope

- Content: The situation of FDI attraction and factors affecting the attraction of FDI capital into Quang Ninh province;
 - Space: Quang Ninh province.
- Duration: The author focuses on researching the situation of FDI attraction in Quang Ninh province from year 2010 to year 2019 and directional solutions for the coming years.

4. The contributions of the thesis

- Theoretical aspect: Systematize the theoretical basis of foreign

investment and attract foreign direct investment capital (FDI capital). The thesis clarifies the nature and role of foreign investment capital, especially for countries or localities receiving investment capital in the context of new development of the provincial-level province today. In order to quantitatively study the possibility of attracting foreign direct investment into Quang Ninh province, the thesis has proposed a linear structure model to study 6 factors affecting the investment intentions of investors in provincal and application of this set of criteria to evaluate factors affecting activities of attracting foreign investment into Quang Ninh province.

- Practical aspect: The thesis analyzes the current situation of FDI attraction in Quang Ninh province; evaluate the results of attracting FDI into Quang Ninh province. Analyzing success and limitations, the causes of success and limitations in attracting FDI into Quang Ninh province. The thesis uses EFA exploratory factor analysis model, linear least squaresbased linear structure model (PLS-SEM) to analyze the factors affecting FDI attraction into Quang Ninh province through linear structure model with "Investment intent" as dependent variable and 6 independent variables as 6 groups of factors converging from many observations including: "infrastructure", "attraction policy" "," Human resources "," location advantages "," living environment "and" quality of public services ". And draw conclusions about the influence and the degree of influence of the factor groups as well as the influence of the observed variables. The thesis clarifies the viewpoint, objectives and orientations to attract foreign direct investment capital into Quang Ninh province and proposes groups of solutions to enhance the attraction of FDI capital into Quang Ninh province in a new context.

From a practical perspective

The thesis analyzes and assesses the situation of FDI attraction in Quang Ninh province on the basis of quantitative research methods and data collection from businesses, thereby analyzing the achieved results as well as the limitations in attracting FDI into Quang Ninh province. The thesis has built a system of points of view and proposed appropriate solutions to increase the attraction of FDI into Quang Ninh province. The proposed solutions are direct solutions specific to Quang Ninh province. Về góc độ thực tiễn.

- 2.1.1. Definition, characteristics and classification of foreign direct investment
- 2.1.1.1 Definition of foreign direct investment

Foreign direct investment means the investor's participation of capital in cash or necessary resources in other economic sectors outside the economy of the investor country, directly participating in organizing and managing, operating ... converting them into capital for production and business in order to seek maximum profits. The resources needed in this concept include tangible assets (machinery, equipment, technological processes,

real estate, valuable contracts and licenses, etc.), intangible assets (intellectual property rights, know-how and management experience...) or financial assets (shares, stocks, bonds, debit notes...).

2.1.1.2. Features of foreign direct investment

Firstly, investors directly manage and control the process of using capital, and have full autonomy in their business activities.

Secondly, FDI associated with production and business activities, foreign direct investment will be converted into machinery, equipment, technology, materials ...

Third, FDI often comes with technology transfer to the investee. Through FDI, the host country can access advanced technical, technology and management experience.

2.1.2. Attract foreign direct investment into the provincial level

2.1.2.1. Views on attracting foreign direct investment into the province

Attracting FDI capital into provincial-level localities is understood as a collection of actions and policies of provincial-level local governments in production specialization in close association with integrated development; In order to attract and stimulate foreign investors that have an intention to invest and make a decision to put FDI capital into the locality and implement it in a certain period. "Strengthening" means making more and stronger. Accordingly, increasing the attraction of FDI into provincial governments is understood as a concentrated and stronger implementation of actions and policies of local governments in order to increase local attractiveness and stimulate foreign investors who intends to invest and makes a decision to invest, thereby increasing the inflow of FDI into the locality, expressed through the number and transaction value of registered FDI contracts, performed in a certain period. Within the scope of the dissertation, the author wants to analyze the situation of FDI attraction in

Quang Ninh province in order to propose solutions to enhance FDI attraction in Quang Ninh province.

2.1.2.2. The content of attracting foreign direct investment into localities at the provincial level

Investment attraction activities are understood as subjective activities of the investee. This includes all major activities aimed at attracting foreign investors so that they intend to invest and decide to transfer investment capital into the country or locality where they receive investment. With the above understanding, the content of investment attraction is the content of those activities and policies, including the following activities: Building targets to attract FDI capital, policies to improve investment environment.; activities, investment incentive policies and activities; investment promotion activities ...




Figure 2.1. The model evaluates factors affecting investors' investment intentions in localities at the provincial level

Analysis of linear structure model based on PLS-SEM (Partial Least Squares - Structural Equation Model). SEM linear structure model is widely used in the fields of psychological research (Anderson and Gerbing, 1988; Hensell and White, 1991), sociology (Lavee, 1988; Lorence and Mortimer, 1985), research the development of children (Anderson, 1987; Biddle and Marlin, 1987) and extensive research in the field of management (Tharenou, Latimer and Conroy, 1994). The PLS-SEM method is used to analyze the influence of factors affecting an enterprise's investment intention on its investment intention.

4.1.2. The socio-economic development results of Quang Ninh province affect to attract foreign direct investment

Quang Ninh Province has issued and implemented effectively Resolution No. 04-NQ/TU of June 30, 2016 on building and developing Ha Long city to 2020, with orientations to 2030, with targets of building and developing Ha Long to become a civilized, friendly and cosmopolitan beach city with an international-class tourism center, affirming its role as a "mind" in the province's spatial development orientation. At the same time, stemming from the requirements of reality and trends, development requirements of the province, in accordance with the Party's strategic plans, guidelines, state laws and people's aspirations, The provincial Party Executive Committee issued Resolution No. 18-NQ/TU of October 2, 2019 on expanding the administrative boundaries and development space of Ha Long city and Hoanh Bo district to maximize the potential, inherent differences and advantages of the two localities, bringing into play all resources, creating a breakthrough as a nucleus to promote Quang Ninh province to become a city directly under the Central Government before 2030. To effectively implement the overall planning on socio-economic

development and adjust the planning on construction of Van Don economic zone till 2045; attract large, motivational projects; high-class tourism and service projects; mobilize and effectively use social resources to complete synchronous and modern infrastructure into Van Don economic zone ... Proposal research and permission of the Government to pilot establishment of a Management Board Van Don economic zone is under the Provincial People's Committee and constructs mechanisms and institutions to operate effectively and efficiently, creating favorable conditions to promote the development of Van Don economic zone. To prioritize resources for investment in developing Mong Cai border-gate economic zone into a free-gate economic zone and a gateway between China and ASEAN for trade, tourism and service activities.

n the period of 2010 - 2019, Quang Ninh province has granted investment registration certificates (IRC) for 85 projects, adjusted capital increase for 39 projects; Total newly attracted capital is over USD 4.9 billion. Besides, after reviewing projects that are not operating or operating poorly, the province has recovered 55 projects with a total investment of over US \$ 421 million. Except for projects that have expired and dissolved before the deadline, up to now, there are 125 valid FDI projects with a total registered capital of over 6.8 billion USD in operation manufacturing business.

In general, the initial FDI projects have met the objectives set out, consistent with the socio-economic development orientation of the province, contributing to economic restructuring towards promoting potentials and streight of the province. Along with attracting new investment projects, many projects after their effective operation have expanded production and business scale and increased investment capital.

4.2.2. Evaluation the status of attracting foreign direct investment into Quang Ninh province

4.2.2.1. Success

FDI capital plays an important role in the growth of the economy in general and for industry in particular, which gradually becomes an important investment source of the province, contributing to the development of industries and creating jobs for workers. FDI contributes to improving the infrastructure system, especially tourism and service infrastructure. FDI contributes to promoting advanced technology transfer, developing a number of important economic sectors of the province such as thermal power, seaports, processing industry ... In the field of agriculture - forestry - fishery, FDI has created a number of new products with high technical content and new plants and breeds. The field of tourism - service acquires many modern ideas and advanced management methods.

The impact of FDI on other economic sectors and localities in the province is also spreading. On the other hand, FDI enterprises also create competitive motivation of domestic enterprises to adapt in the context of globalization.

FDI contributes significantly to the state budget and macro balances. Along with the development of FDI enterprises, the contribution of the FDI sector to the budget is increasing. FDI has a positive impact on economic balances such as budget balance, expansion of indirect foreign currency revenue through international visitors, land rents, money to buy machinery and materials, etc.

FDI plays an important role in creating jobs, increasing labor productivity, and improving human resources. A part of local labor is admitted to work in FDI enterprises which are fostered, trained in skills and foreign languages, contributing to improving the quality of human resources, gradually replacing important positions, the key of the business.

In addition, the FDI business community has made positive contributions to charitable activities, social activities, administrative procedures reform, participation in mass movement activities: sports, culture, arts, festivals, big events ... of the province.

4.2.2.2. *Limitation*

Despite achieving the above-mentioned important results, the FDI activities in Quang Ninh in recent years still have the following limitations:

4.2.2.3. The cause of limitations

- Seventh, planning and administrative reform still faces many shortcomings.

Analysis of linear structure model based on PLS-SEM partial least squares

After having the results of checking the conformity of the whole model, the author put all satisfied observations and potential variables into the model for SEM analysis and tested the research hypotheses. The test results of the research hypotheses were assessed with a significance of 5% and tested by the bootstrapping procedure with 5000 subsamples and the significance level of 5%. The model test results obtained are as follows:




Figure 4.1. Research model results

The results show that the independent variables have a significant impact on the dependent variable. Specifically: The investment attraction policy has the strongest impact on the investment intentions of FDI enterprises (t=15,853, p<0.001); infrastructure, public services and human resources have a strong impact on the investment intentions of FDI enterprises, in particular for effective infrastructure (t=12,033, p<0.001), successful public services (t=11,777, p<0.001), human resources have results (t=9,548, p<0.001); and finally, habitat that affects investment intentions (t=0.910, p<0.001). All p values are equal to 0 (p<0.001), proving that the results of testing hypotheses are reliable and all hypotheses are accepted.

CHAPTER 5: SOLUTIONS TO ENHANCE ATTRACTION OF FOREIGN DIRECT INVESTMENT INTO QUANG NINH PROVINCE IN THE CONTEXT OF NEW DEVELOPMENT

5.1. Orientation of Quang Ninh province to attract foreign direct investment

5.1.1. The new development context affects the attraction of foreign direct investment into Quang Ninh province

In the context of development, the ability and intention to invest abroad by multinational corporations are affected by economic difficulties leading to tightening credit policies in investing countries, reducing market expectations, reducing financial values due to the stock market going down and the profits of corporations decreased. In addition, corporations also face unpredictable changes in policy.

Vietnam has signed many significant trade agreements: Vietnam's trade agreement network provides opportunities to access important markets such as Japan, South Korea, and India, which is not only an important role for Vietnam's exports but also the attractiveness of FDI. Effective foreign investors will look to produce goods or services in Vietnam for export to third markets. Therefore, the preferential and guaranteed market access opportunities provided by the FTA network signed by Vietnam is an advantage to attract investors.

The Viet Nam Vision 2030 Report emphasized the need to move up the global value chain by focusing on building domestic link chains, adding value, improving skills and innovating. Stemming from the 2011-2035 socioeconomic development strategy, towards prosperity, creativity and equality,

Vietnam built a new generation FDI strategy with a vision to 2020-2030. In which, it is important to promote the spillover of FDI inflows, to increase the added value of exports, to make the most of the benefits brought by FTAs, from which Vietnamese enterprises integrate. deeper into global value chains.

In addition, in the context of the strong industrial revolution 4.0, the impact of these breakthrough technologies is evidence that there is a constant need for market acumen as well as the dynamism to sustain Vietnam becomes a competitive destination for FDI attraction, as well as the ability to create an environment for new industries to develop quickly.

5.1.2. Prospects to attract foreign direct investment into Quang Ninh province in the context of new development

In order to achieve the socio-economic development goals of the province, it is necessary not only to have more intensive participation of the FDI sector but also the improvement of the quality of FDI activities in the economy. Not only in the international environment but also within the nation, the competition to attract FDI is increasing between countries and localities within one country. Therefore, it is imperative to find an FDI orientation for Quang Ninh, creating a new direction for the whole period. Being aware of this problem, based on the analysis of the world FDI and thoroughly grasping the viewpoint and general orientation of FDI of the country, serving the socio-economic development goals of the whole province, Quang Ninh has thoroughly grasped the new direction in attracting FDI as follows: The orientation of FDI attraction of the province must serve the goal of renewing the development growth model in width to depth, from relying mainly on increasing investment capital, exploiting natural resources and labor to rely on efficiency, productivity, quality and

competitiveness. FDI must increase the quality and scale of an investment project. Striving for technology content in the projects accounting for 45-50%, shifting from developing mainly heavy industries to developing high-tech auxiliary industries, minimizing environmental impacts, minimizing crude, maximizing the advantages of Ha Long Bay and Bai Tu Long Bay.

CONCLUSION

In Vietnam in general and localities in particular are in need of a lot of capital for development investment because the internal accumulation in the economy is still low, so it is indispensable to attract capital from the outside. Quang Ninh has many advantages to develop a variety of economic sectors, is a gateway to the sea for the whole country in the North and the area of import and export goods, economic exchanges, is an attractive destination for many domestic and foreign investors. Recently, thanks to the positive changes in investment capital for socio-economic development of Quang Ninh province, however, foreign direct investment in Quang Ninh is still limited, even the investment is less stable and there is a decrease. With the characteristics and the actual situation of attracting FDI capital in Quang Ninh province, promoting this capital attraction is very necessary and important, which is the basis to promote the economy of Quang Ninh province. The thesis has performed the following main tasks:

Develop a common theory of attracting FDI into the provincial level, including: The theory of FDI, the theory of FDI attraction, the content of FDI attraction, theories on factors affecting the attraction of capital FDI (in which, the thesis applies Dunning's OLI theory to build EFA and PLS SEM research models in the analysis of the sample).

- Analyze and synthesize experiences in attracting FDI from some countries, of some localities in the country and draw lessons for Quang Ninh province
- Analyze socio-economic characteristics of Quang Ninh province affecting FDI attraction, analyze the situation of FDI attraction in Quang

Ninh province, thereby point out the results and existent in attracting FDI capital of the province.

- Based on the analysis of FDI investment data in Quang Ninh province, the author used EFA and PLS SEM models to analyze and evaluate the factors affecting FDI attraction in Quang Ninh province and evaluate the influence level of factors through the general evaluation variable of "Investment intent" of investors.
- The author has carefully analyzed the international and domestic situation affecting the attraction of FDI into Quang Ninh province. Also pointed out the prospect of attracting FDI into Quang Ninh province.
- The author has proposed 7 groups of solutions to increase the attraction of FDI into Quang Ninh province, including: Promote the development of policies to attract investment in Quang Ninh province; Completing infrastructure system; Improve the quality of human resources; Improve the quality of public services; Complete socio-economic development planning; Innovating, promoting and improving the effectiveness of investment promotion; Group of environmental solutions.

With the system of arguments, analysis of the current situation and proposing solutions of the thesis "Investigation the attraction of foreign direct investment into Quang Ninh province in the context of new development", the author hopes to close contribute a part of their efforts to make a voice for attracting FDI capital into Quang Ninh province in the near future. The author wishes to receive the comments from experts, researchers at home and abroad to continue to improve and further develop his research.
